



FIFRA Section 2(ee) Recommendation for the State of Pennsylvania

MilStop®

Use: For the control of certain insect pests

Directions for Insecticidal Use

This recommendation is made as is permitted under FIFRA Section 2(ee) and has not been submitted to or approved by the EPA. The recommendation contains directions for use which do not appear on the EPA registered label of MilStop® Broad Spectrum Foliar Fungicide. User must refer to the federally approved label for MilStop Broad Spectrum Foliar Fungicide and read and follow all directions for use, restrictions, and precautions.

For insecticidal use, apply MilStop Broad Spectrum Foliar Fungicide using the same rates and application instructions provided for fungicidal use. Pay particular attention to all precautions and special instructions included in that label and apply only to the crops, plants and use sites listed there.

Application Timing

Insecticidal applications should be made as soon as the pest problem is noticed. Apply MilStop Broad Spectrum Foliar Fungicide using a 7-14 day interval depending upon the severity of the pest problem. The 7 day interval should be used until the problem is reduced before reverting to the 14 day interval for longer term control. For best results, schedule applications for the early to mid-morning or late afternoon. This will ensure that the sprays thoroughly wet the pests to be controlled, which are often sedentary on the foliage at these times, and to minimize plant stress.

Preharvest Interval

MilStop Broad Spectrum Foliar Fungicide can be applied up to and including the day of harvest.

Special Instructions

Higher water volumes provide improved insect control. Use the higher label rate where severe pest pressure exists. Also, the higher rate should be used where infestations occur later in crop development, or where pest pressure is continuous.

MilStop Broad Spectrum Foliar Fungicide has been shown to control the following insect pests:

Bird Cherry-oat aphid (*Ropalosium padi*)
English grain aphid (*Sitobion avenae*)
Green peach aphid (*Myzus persicae*)
Mealybugs (*Planococcus citri*)
Rose chafer (*Macrodactylus subspinosus*)
Brown stinkbug (*Euschistus servus*)
Whitefly – incl. "Q" Biotype (*Bemisa argentifolia*)

Corn leaf aphid (*Ropalosium maidus*)
Green bug aphid (*Schizaphis graminum*)
Rose grain aphid (*Melophium dirhodum*)
Mites, spider (*Tetranychus telarius*)
Thrips (*Frankliniella occidentalis*)
Green Stinkbug (*Acrosternum hilare*)
